
- Our objective is to build a multidimensional framework of contents, legal and organizational aspects and quality criteria







The performance profile of the equitherapist shows the areas of competence in which the prospective equitherapist needs to acquire sufficient knowledge, skills and personal development during their studies. These areas of competence are also the criteria according to which the equitherapist is evaluated in the interim and final examinations of the course.







- A step-by-step, cyclical process in phases:
- The therapeutic process is defined as a stepby-step, cyclical process, resulting
- from (1) the interplay between therapist client - horse within a secure and inviting
- situation, adjusted to suit (2) the individual problems of the client and
- (3) the level of therapy at the given moment, involving (4) the exercises and, as
- appropriate, (5) the intervention of the therapist, as well as (6) the reaction of
- * the client to this.
