STRAPATE RANCZO is an animotherapeutic centre in central Poland. Main goal: to help people with mental problems (for poor people and in hard social conditions), studying of working of pet assisted therapy with educating and training in therapeutic riding work for specialists. We concentrate on research and educational work in AAT with the goal to achieve the acceptance of therapeutic riding as effective therapeutic method of big preventive value. Our organization provides special workshops and self-experience trainings for specialists in the field of therapeutic riding. We provide studying and comparing of diagnostic, methodical, didactic process by self-experience trainings for specialists in therapeutic riding. Ad inde we practice cooperating with parents, schools, mental centres, also diagnostic work, therapeutic work – therapeutic riding, dog assisted therapy, studying of effects by this kind of therapy methods. The outcomes of this are published in scientific magazines. The outcomes of our work are not only therapy effects for clients but also the multiple verification of this kind of therapy methods, of specialist's education and trainings in therapeutic riding, work and presentation and propagation of our experiences at European and world rank. We practice teaching, dealing with children with behaviour and learning difficulties and disabled children and their integration, counselling for children, parents, teachers with problems, dealing with bullying and prevention, using of drug and criminality prevention, cooperation with social workers. Fancy of therapist's education and training's skills of therapeutic riding in Europe, developing of specifically diagnostic methods for effective at trainings for specialists, developing and confirming of self experience's training model - programs with welldefined level of quality and competencies for aa therapists (this means in particular complex diagnostic, didactic and methodical model for aat's supervisors, teachers in EU countries). We want to develop an education model responding to the needs of the clients and organizations. This way we can help improve good practices in the EU. This is where the influence on right political decisions in EU countries through adequate supporting of therapeutic riding is important. With the help of our research, we want to define well animals' adaption to this kind of work and also to define the practice according to the animals' well-being.

SHA is a professional organization in the Slovak republic, it covers professionals working in this field as hippotherapists (physiotherapists, psychiatrists, psycho-therapists, psychologists, remedial - special - social educators)

SHA is also a schooling and training centre. It offers professional education for new hippotherapists (in cooperation with the Slovak Health University in Bratislava). It organizes Slovak Hippotherapeutic Conferences every second year (not only with Slovak speakers, but also with speakers from middle and eastern Europe). Our role in the project: SHA is organizing educational courses and trainings in AMAT for therapists. We publish our research studies in journals and present our experience in the public media. We create new professional didactic material for clients (actually it is a workbook for preschool children with a disability). With our experience, we can help to compare different systems of education in therapeutic riding across the EU, to develop specific diagnostic methods for effective trainings in AMAT for specialists. We have started with educational and training changes in therapeutic riding education system in our country. Currently our ambition is to make educational and training courses for future therapists more effective. We can more specifically provide Polish proofing and developing diagnostic methods as well as trainings methods. The other specific issue is the function and training of the horse for therapeutic riding. We are studying this topic and we would like to continue this research within the frame of the EU project. Information is often very isolated and available only with difficulty. We therefore feel the need for more networking.
